Please note: Issuance of a Temporary Approval does not create a vested right in the holder to either an extension of the Temporary Approval, or to the issuance of a subsequent non-temporary License. Temporary Approval authorizes the Applicant to conduct Commercial Cannabis Activities but does not waive or otherwise circumvent other City requirements or necessary permits from the City or other public agencies, including, but not limited, to a Certificate of Occupancy, health permit from the County of Los Angeles, or authorization from the State. If at any time during the processing of an Application it is discovered that an Application has been improperly prepared or required information has not been submitted in accordance with the LAMC or Rules and Regulations, upon notification to the Applicant, processing shall be suspended and shall not continue until the Application has been corrected or the required information provided. (LAMC § 104.05(d).) A material misrepresentation or false statement on this form, or a failure to knowingly disclose a material fact, is also grounds for denial of a License. (LAMC § 104.04(a)(3).) Every License, including Temporary Approvals, shall be renewed annually. If a License is not timely renewed, it shall expire after 11:59 p.m. on December 31 for the year issued. (LAMC § 104.12(a).)

I understand that submission of false or misleading information or the failure to disclose material facts may result in denial of the application, the suspension or revocation of the license, and/or any other penalties allowed by law.
